INSTRUCTIONS

1. Please follow the Society's Bylaws and Rules while completing this application (see page 2).
2. Please answer the following questions using single space and 11-point font. Some suggested fonts are Arial, Scala and Georgia, or something similar. You may use bullets, underline, bold, and colors to amplify your application.
3. If you have any questions while filling out this application, you may consult with the ANS Honors and Awards (H&A) Committee chair at honors@ans.org.
4. A nomination rejected for the first time may be resubmitted for reevaluation within two years from the original submission date. Nominators should update the nomination package before it is submitted for reevaluation. If the candidate is not approved on the second ballot, a new nomination may not be submitted for evaluation in less than five years from the resubmission date.
5. If your nominee is rejected, you may ask for comments identifying areas for improvement.

NOTE: The Fellow nomination package will consist of this nomination form and letters from the sponsors. Please keep in mind that all supporting information for the nomination form is to be concise, and instructions followed. Noncompliance with these requirements will result in the nomination package being returned to the principal sponsor without consideration of the nomination. Addended lists of publications, accomplishments, resumes and other such material will not be included in the packet to the review committee. Only include supporting letters from the principal sponsor and the sponsors listed on page 3 of this nomination form. Additional letters will not be included in the packet to the review committee.

B3.3 (a) QUALIFICATIONS FOR FELLOW MEMBERSHIP GRADE

Qualification for Fellow grade of membership shall be determined in accordance with the following principles

FELLOWS—Persons at least 35 years of age and possessing at least ten (10) years of professional experience, who, at the time of nomination must have been a member in Good Standing of the Society for at least five (5) continuous years immediately prior to nomination, who shall have acknowledged scientific, engineering, or leadership attainments, and who shall have advanced the science or art of nuclear technology by (1) notable original research or invention in the nuclear field, or (2) scientific or technical leadership in a nuclear enterprise of substantial scope, or (3) outstanding leadership as a teacher in the nuclear field, or (4) outstanding leadership in design, engineering, or operations in the nuclear power or other-related field, or (5) outstanding efforts in the areas of nuclear health, safety, or regulation. Nominees cannot be current members of the Board of Directors or the Honors and Awards Committee.

R3.3.8 - Promotion to Fellow

(a) Nomination Procedure - Promotion to Fellow shall be initiated by nomination by one (1) principal sponsor and no less than five (5) but no more than seven (7) Fellows or Professional Members who, as sponsors, shall have personal knowledge of the candidate's qualifications and contributions toward the objectives of the Society. Nomination shall be made on a designated form. Members of the Board of Directors and the Honors and Awards Committee are not eligible for nomination as Fellows during their terms of service. In addition, members of the Board of Directors and Honors and Awards Committee shall not nominate, sponsor or endorse ANS Members for Fellow Grade during their terms of service.

(b) Honors and Awards Committee Review - Nominations with supporting material shall be submitted to the Honors and Awards Committee, and may be referred by that committee to the Membership Committee for review and recommendation. The Honors and Awards Committee shall consider the nomination and make its recommendation to the Board of Directors.

(c) Board of Directors Election - Election to Fellow is by a majority vote of the total membership of the Board of Directors. However, if more than 15% of the Board of Directors cast a negative vote, the candidate shall be disqualified.

(d) Resubmission - At the discretion of the Honors and Awards Committee candidates failing to receive sufficient affirmative votes may be resubmitted for election at any time. Those rejected because of excessive negative votes may be resubmitted within two (2) years following the date of the ballot. If the candidate is not approved on the second ballot, a new submission may not be submitted for evaluation in less than five (5) years from the resubmission date.

(e) Acceptance Required - The promotion to Fellow shall become valid if an acceptance is received from the nominee within six (6) months following the date of their notification of election.
